## Satisfaction Survey Results Are In

Members scored Benton REA 89 out of 100 possible points in a recent American Consumer Satisfaction Index (ACSI) survey. Among other Touchstone Energy Cooperatives, Benton REA exceeded the national average ACSI score of 78.

"We are thrilled with the survey results and our satisfaction score," said Troy Berglund, Benton REA's community development and member relations manager, "but the survey has also shown us areas in which we can improve to better serve our members."

A random selection of members were mailed a postcard in early July asking for their participation in the survey. 250 members from 13 different zip codes completed the 13-question survey either online or by phone.

The survey concluded that drivers of cooperative members' satisfaction include (1) providing good value for the money, (2) being involved in the community,



(3) supporting renewable energy like solar and wind power, (4) offering energy efficient programs to help members save money and (5) communicating important cooperative information.

"Benton REA seeks to excel in all of these areas, because our members have told us they matter," said Berglund.

## **Rates Remain Stable**

Several local utilities recently announcing electric rate increases that will become effective this fall. To avoid any confusion for Benton REA members, <u>Benton</u> <u>REA will NOT raise its electric</u> rates now or in the near future.

Other utilities have announced electric rate increases due to wholesale electric cost increases as the Bonneville Power Administration (BPA) recently announced a 5.4 percent increase in wholesale electric rates, effective October of 2017.

"Benton REA is not immune to the BPA rate increase because Benton REA receives most of its wholesale power from BPA," said Benton REA general manager Mike Bradshaw. "In fact, BPA's electric rates will increase by five percent to Benton REA. However, the Benton REA management and Board of Trustees have chosen to avoid passing this rate increase though to our members."

## How is Benton REA able to avoid the rate increase?

There are a combination of reasons why Benton REA is able to absorb the wholesale power increase and maintain stable electric rates for its members. First is budgeting. The BPA rate increase was expected and Benton REA made budgetary adjustments to help mitigate the increase. The second is cost savings. For example, funds from the recent sale of service area within the Yakama Nation Indian Reservation were used to pay down debt, resulting in debt service cost savings.

## The BPA rate increase is a concern for Benton REA and its members.

Even though Benton REA is able to absorb this BPA rate increase, this continues a very concerning trend of BPA rate increases. During the last 10 years, BPA's rates have increased nearly by 40 percent and that trend is expected to continue. This trend of BPA rate increases was the primary topic Benton REA took back to Washington, D.C. earlier this year as we met with our congressional delegation. Benton REA will continue to work with BPA, congress and others to help stop this trend. Our goal is to maintain stable rates for our members, and we will continue to work diligently toward that goal.



# **Five Scholarships up for Grabs**



Applications for Benton REA's 2017-2018 scholarships are due Dec. 1, 2017.

Each year, Benton REA awards up to five separate \$8,000 continuing education scholarships to qualifying Benton REA members or their children whose main residence is in Benton, Yakima or Lewis counties and who are graduating high school seniors.

Academic scholarships can be used for a 4-year post-secondary education. Trade & Technical scholarships can be used for a 2-year certificate program. Scholarships are judged based on academic performance as well as a written essay.

Benton REA's scholarship program is fully funded through unclaimed capital credits.



## **Co-ops Commit To Members**

Benton REA is joining 30,000 cooperatives nationwide in October to celebrate National Co-op Month, which recognizes the many ways cooperatives are committed to strengthening the local communities they serve. "Co-ops Commit" is the theme for this year's celebration, spotlighting the countless ways cooperatives meet the needs of their members and communities.

Benton REA delivers electricity to more than 10,000 members in our three-county service area. It is our mission to provide Benton REA's members with affordable and reliable energy and other memberdriven compatible services. Benton REA strives to enhance the quality of life for all members.

"There are many benefits to receiving electricity from Benton REA such as our reliability record, our energy conservation programs and our commitment to community," says general manager Mike Bradshaw. "But, the one thing that makes us a different kind of utility is the return on your investment." Benton REA is proud to be the only utility in the area committed to returning margins (net income) to its members. That return on members' investment is called "capital credits".

Rural America is served by a network of about 1,000 electric cooperatives, most of which were formed in the 1930s and 40s to bring electricity to farms and rural communities that large, investor-owned power companies had no interest in serving because of the higher costs involved in serving low-population and low-density areas.

Together, electric cooperatives are committed to our communities, to education, to safety and to impacting the world for good. We are committed to you, our members, and 2017 marks Benton REA' 80th anniversary of that commitment.

# **\$100 Smart Thermostat Rebate**

Put \$100 back in your wallet when you purchase a qualifying smart thermostat.

Benton REA members who currently have an electric furnace or heat pump as their primary source of heat can receive a \$100 rebate with the purchase of one of the following smart thermostats:

- Nest 3rd Generation
- ecobee3 (not ecobee3 lite)
- ecobee4

"Smart thermostats can help members save energy because they have the capability of programming themselves based on the homeowner's lifestyle to regulate the home's temperature throughout the day," said Eric Miller, energy advisor with Benton REA. "These thermostats can also be controlled remotely with a smartphone."

Once purchased, members can choose to self-install their smart thermostat or hire a professional. Those who choose to have their thermostat installed professionally will receive an additional \$25 incentive from Benton REA. To receive a list of qualifying professionals, call 509-786-8265.

Members must apply for this rebate within 6 months after the purchase date. Limit two per household. Thermostats that control cooling-only systems are not eligible for an incentive.
